COUNTY MANAGER'S RECOMMENDATION OR COMMENTS: Recommend Approval
SUMMARY OF INFORMATION:
On September 14, 2015, the Forsyth County Board of Commissioners authorized the execution of a contract between Forsyth County and Frank L. Blum Construction Company as Construction Manager at Risk for the Central Library Reconstruction Project.
On July 11, 2016, the Forsyth County Board of Commissioners authorized the execution of a contract between Forsyth County and Landmark Builders of the Triad, Inc. as Construction Manager at Risk for the Public Safety Center Probation and Parole, Emergency Operations Center, and 911 Call Center Project.
Within a Construction Manager at Risk delivery method there are generally two types of contingency funds, contractor managed included in the guaranteed maximum price and owner managed. Owner managed contingency funds are set aside to cover unanticipated owner directed scope changes, errors and omissions, and/or unforeseen code issues after the establishment of the guaranteed maximum price.
Both sets of contingency are managed and only authorized to be spent upon the approval by the County Manager through the recommendation of the Construction Manager.
At the time each of the above referenced contracts were authorized, owner's contingency funds were not established.
For the Central Library Reconstruction Project owner's contingency is recommended to be set at an amount not to exceed \$820,000 or 3.8% of the guaranteed maximum price. For the Public Safety Center Probation and Parole, Emergency Operations Center, and 911 Call Center Project owner's contingency is recommended to be set at an amount not to exceed \$50,000 or 1% of the guaranteed maximum price.
It is recommended by the County Manager and the Forsyth County General Services Director that the County Manager be authorized to sign change orders in an amount not to exceed a total of \$820,000 for the Central Library Reconstruction Project and in an amount not to exceed a total of \$50,000 for the Public Safety Center Probation and Parole Project.

BE IT FURTHER RESOLVED that the County Manager is hereby authorized to sign change orders under the owner's contingency fund in an amount not to exceed a total of \$820,000 for the Central Library Reconstruction Project.

BE IT FURTHER RESOLVED that the County Manager will submit reports to the Forsyth County Board of Commissioners of all change orders under the owner's contingency fund.

BE IT FURTHER RESOLVED that the County Manager is hereby authorized to sign change orders under the owner's contingency fund in an amount not to exceed a total of \$50,000 for the Public Safety Center Probation and Parole, Emergency Operations Center, and 911 Call Center Project.

BE IT FURTHER RESOLVED that the County Manager will submit reports to the Forsyth County Board of Commissioners of all change orders under the owner's contingency fund.
