**COUNTY MANAGER'S RECOMMENDATION OR COMMENTS:**

**SUMMARY OF INFORMATION:**

A. In 2010, Forsyth County voters approved a bond referendum in the amount of \$40,000,000 for acquiring, constructing, expanding and renovating library buildings and other library facilities. \$34,000,000 of the Library Bonds were issued and the remaining \$6,000,000 was made available through pay-go funding and bond premium.

A 3.8% or \$820,000 contingency was encumbered in the Central Library construction project budget for owner-approved unanticipated change orders due to regulatory requirements, unforeseen site conditions, or contractor-initiated changes to accelerate project completion. At the close out of the Blum construction contract, once the sales tax reimbursement certificate was provided to the County, a balance of \$203,320 of that contingency remains that can be released to other library bond projects in the 2011 Library Bond Capital Projects Ordinance.

Staff recommends the balance of \$203,320 be transferred to the Clemmons Branch Library project allocation to facilitate that project's completion. These funds will be used to mitigate value engineering work and account for inflationary growth in the library construction cost. Additionally, staff recommends that \$36,240 from private donations for the Clemmons branch be appropriated to the Clemmons Branch Library project allocation.

B. A resolution recognizing the generous donations of Steve and Cat McSwain and the bequest of Miriam Brenner toward the Clemmons Branch Library project and naming the Children's Storytime & Craft Room and the Quiet Room at the new library in recognition of their gifts.
