## ORDINANCE NAMING AN UNNAMED ROAD SEGMENT LOCATED OFF BELEWS CREEK ROAD WITHIN THE UNINCORPORATED AREA OF FORSYTH COUNTY, CRUZ WAY (MAPFORSYTH ADDRESSING TEAM)

**WHEREAS** a Forsyth County property owner has requested a road segment located off Belews Creek Road, adjacent to her property, within the unincorporated area of Forsyth County, be named Cruz Way;

**WHEREAS** the Addressing Team of MapForsyth received no opposition in the proposed road name from the adjoining property owners;

WHEREAS the proposed road name does not pose any address range or road name duplication issues; and

WHEREAS pursuant to the provisions of N.C.G.S. 153A-239.1, at least ten (10) days prior to conducting the public hearing to name the said road segment, Forsyth County caused notice of the time, place, and subject matter of the hearing on this proposed road naming to be prominently posted at the Forsyth County Courthouse and in at least two public places in the township where the road is located, and to be published in a newspaper of general circulation published in Forsyth County;

**NOW, THEREFORE, BE IT ORDAINED,** by the Forsyth County Board of Commissioners, after providing notice and conducting a public hearing as required by law, that the road segment located off Belews Creek Road within the unincorporated area of Forsyth County, as further identified on the attached map, is hereby named Cruz Way;

**BE IT FURTHER ORDAINED,** that after naming Cruz Way, Forsyth County shall cause notice of this action to be given to the local Postmaster with jurisdiction over the said road, to the N.C. Board of Transportation, and to any municipality within five miles of the said road as required by law; and

**BE IT FURTHER ORDAINED,** that this Ordinance shall become effective upon its adoption.

Adopted this the 1<sup>st</sup> day of April 2021.
