## RESOLUTION APPOINTING A FORSYTH COUNTY DEPUTY TAX ASSESSOR/COLLECTOR UPON THE RECOMMENDATION OF THE FORSYTH COUNTY TAX ASSESSOR/COLLECTOR PURSUANT TO THE PROVISIONS OF N.C.G.S. 105-297 AND N.C.G.S. 105-349

WHEREAS, N.C.G.S. 105-297 authorizes the Board of County Commissioners, upon the recommendation of the Tax Assessor/Collector to appoint one or more Assistant Tax Assessors; and

WHEREAS, N.C.G.S. 105-297 further provides that the Board may delegate to Assistant Assessors appointed under this section, the responsibility for the appraisal of real property, the listing and appraisal of business property, or such other duties as the Board deems advisable; and

WHEREAS, N.C.G.S. 105-349 authorizes the governing body of a County to appoint one or more deputy tax collectors and to establish their terms of office, compensation, and bonding requirements; and

WHEREAS, N.C.G.S. 105-349 further provides that a deputy tax collector shall have authority to perform, under the direction of the tax collector, any act that the tax collector may perform unless the governing body appointing the deputy specifically limits the scope of the deputy's authority; and

WHEREAS, N.C.G.S. 105-349 requires every deputy tax collector, as the holder of an office, to take the oath of office required by Article VI, Section 7 of the North Carolina Constitution with the added phrase: "that I will not allow my actions as tax collector to be influenced by personal or political friendships or obligations"; and

WHEREAS, John Burgiss, the Forsyth County Tax Assessor/Collector recommends that the Forsyth County Board of Commissioners appoint Michael Pollock to the position of Forsyth County Deputy Tax Assessor/Collector, effective March 28, 2015, for a term of four years, at a beginning salary of \$2,717.60 per pay period, and with a bond in the amount of \$150,000;

**NOW, THEREFORE, BE IT RESOLVED** that the Forsyth County Board of Commissioners pursuant to the provisions of N.C.G.S. 105-297 and N.C.G.S. 105-349, hereby appoints Michael Pollock to the position and office of Forsyth County Deputy Tax Assessor/Collector, effective March 28, 2015, for a term of four years, at a beginning salary of \$2,717.60 per pay period, and with a bond in the amount of \$150,000.
