## FORSYTH COUNTY BOARD OF ELECTIONS Meeting Minutes November 12, 2024 – 2:00 p.m.

## **Meeting Called to Order**

A meeting of the Forsyth County Board of Elections was called to order in the 2<sup>nd</sup> Floor Board Room on Tuesday, November 12, 2024, at **2:09** p.m., Chairperson Robert Durrah, Jr. presiding.

#### **Voter Challenge Updates**

Director Tim Tsujii presented to the Board that there was a total of 77 voter challenges to date. Four challenges are related to absentee ballots cast and the voter then also voted on election day, 42 voter challenges are due to voters early voting in Forsyth County but has voter registrations removed in other counties, 18 voter challenges were due early voters with felony convictions, and 13 voter challenges are due to deceased voters who voted during early voting and passed away before election day.

#### Adoption of Resolution to Authorize and Delegate to Staff Ballot Retrieval Process

Mr. Tsujii presented to the Board the resolution to authorize and delegate staff for the ballot retrieval process for ballots of voters who have been challenged. The retrieval will be done by a bipartisan team and documented per N.C.G.S. 163-162.1(e). Member Draper moved to adopt the resolution as presented; Vice Chair Jourdan seconded. **Motion carried unanimously.** 

#### **Other Business**

Board Clerk, Tricia Starkey, reviewed the upcoming meeting schedule.

Chairperson Robert Durrah reminded the Board that all members were required to attend the Canvass Meeting per N.C. General Statute 163-89(e) and that he mailed all members a reminder letter on October 31, 2024.

Forsyth County Board of Elections – Board Meeting November 12, 2024 Mr. Tsujii reviewed the write-in votes tallying process with the Board.
